## **Exemption Request - Order 10-2020 - Single Site Exemption**

Whereas the Chief Medical Officer of Health (CMOH) initiated an investigation into the existence of COVID-19 within the Province of Alberta.

Whereas the investigation has confirmed that COVID-19 is present in Alberta.

Whereas under section 29(2)(b)(i) of the *Public Health Act*, the CMOH may make an order pursuant to her authority under s. 29(2.1) of the *Public Health Act*.

Further to the above, the CMOH, pursuant to her authority under s. 29(2.1) of the *Public Health Act*, made Record of Decision – CMOH Order 10-2020 on April 10, 2020, which was subsequently amended by Record of Decision – CMOH Order 23-2020 on May 25, 2020, which was subsequently amended by Record of Decision – CMOH Order 32-2020 which came into effect on September 17, 2020 (the Order) to suppress COVID-19 in those who may have already been infected with COVID-19; protect those who have not already been exposed to COVID-19; break the chain of transmission and prevent the spread of COVID-19; and remove the source of infection.

Pursuant to Part 1 - Section 1 of the Order, the operators and any contractors operating within a health care facility must restrict the movement of staff members among health care facilities by ensuring that each staff member works in only one health care facility.

Pursuant to the "Deployment of Staff and Resources" standards in Part 2 of the Order, in the case of a confirmed COVID-19 outbreak, operators must authorize and deploy additional resources to manage the outbreak, as needed, to provide safe resident care and services as well as a safe workplace for staff.

Pursuant to Part 2 – Section 9(a) of the Order, all operators of a health care facility located in the Province of Alberta must comply with the operational and outbreak standards attached as Appendix A to the same.

Pursuant to Part 1 - Section 8, the CMOH may exempt in writing an operator, contractor, or staff member of a health care facility from the application of Part 1 of the Order on a case-by case basis.

Pursuant to Part 2 – Section 13 of the Order, an operator of a health care facility may be exempted from the application of Part 2 of the Order on a case-by-case basis.

The Office of CMOH has received multiple requests from AHS Medical Officers of Health and AHS Continuing Care Leadership requesting that single site exemptions be issued where sites are experiencing staffing constraints due to the quarantine or isolation of a significant proportion of their staff members. These requests ask that health care facilities experiencing critical staffing constraints be exempt from the Order, specifically the application of Part 1 – Section 1 and from the "Staff Working at Single Facility" standards set out in Part 2 of the Order

These exemption requests received by the Office of the Chief Medical Officer of Health from the impacted health care facility, or through the AHS MOH or the AHS Continuing Care Zone Executive Leadership, are being evaluated through an internal validation and approval process which includes:

- Validation of the incoming request by the Compliance and Monitoring Branch and the Continuing Care Branch which is coordinated by a designated Alberta Health team member (Designated Team Member);
- Recommendation is sent to CMOH via email by the Designated Team Member;
- CMOH approval or denial is sent to the Designated Team Member and Alberta Health program areas via email;
- Approved site added to the Schedule A by the Designated Team Member; and
- Requestor and the impacted health care facility are advised as to outcome of their request for a single site exemption by the Designated Team Member.

The categories of staff that are being asked to be redeployed include: RNs, LPNs, HCAs and staff from support services including nutrition food services and environmental services. The health care facilities that are requesting site exemptions are also being required to put in place measures to track all shared employees who work at more than one health care facility (i.e. names, dates, times, designation of staff) as a condition for a site exemption.

Therefore, pursuant to Section 8 of the Order, I am satisfied that the facilities that have received written approval from the CMOH, and as identified in Schedule A, consisting of health care facilities that have been validated to have critical staffing constraints due to quarantine and isolation of their employees are exempt from Part 1 of the Order and the "Staff Working at Single Facility" standards set out in Part 2 of the Order subject to the following conditions:

- I. Subject to paragraphs II to V staff members from operators, contractors or agencies identified in Schedule A, as may be updated from time to time, may be redeployed where the operator, contractor or agency as the case may be has received written approval from the CMOH to redeploy its staff for the purpose of providing services and support care delivery at a health care facility impacted by critical staffing constraints due to isolation and quarantine of their employees (Impacted Facility) for a set period of time are exempt from Part 1 of the Order and the "Staff Working at Single Facility" standards set out in Part 2 of the Order;
- II. Specified staff members approved by the local AHS MOH or Zone Continuing Care Executive Director or designate are permitted to work at the Impacted Facility in

- addition to their regular health care facility to ensure that safe and quality care continues to be provided at the Impacted Facility.
- III. Health care facility operators, contractors, agencies and their staff members who are subject to this exemption are to make every possible effort to have staff members continue to work at only one health care facility;
- IV. Health care facility operators, contractors, agencies and their staff members who are subject to this exemption are to make every possible effort to assign staff (cohort), to the greatest extent possible, to either:
  - Exclusively provide care/service for residents who are not in quarantine or isolation, or
  - Exclusively provide care/service for residents who are in quarantine or isolation; and
- V. The Impacted Facility shall submit reports similar to the example in Schedule B, at least weekly after this exemption comes into effect, to Alberta Heath - Attention: Executive Director of the Continuing Care Branch and the Executive Director Compliance and Monitoring that shall document and identify the efforts being made by that facility to have staff members continue to work at only one health care facility.

Although operators, contractors and staff members described in paragraph 1 are exempt from Part 1 of the Order and from the "Staff Working at Single Facility" standards set out in Part 2 of the Order, all persons providing or responsible for services to the Albertans in these health care facilities must promote appropriate hygiene, distancing of 2 metres from other people where possible, and other measures identified by public health authorities to protect these persons and Albertans from further transmission of COVID-19.

The exemption provided by this letter may be terminated or modified by the CMOH in writing without notice at any time and for any reason as determined by the CMOH.

This exemption comes into effect on the date the facility is listed in Schedule A and continues for six weeks at which time facilities must request an extension from CMOH.

We trust this is satisfactory.
