- 1. Do you agree with calls to scrap the draft curriculum and start over to develop a curriculum that is accurate in capturing Alberta's colonial history, diverse present, and modernized to reflect the world we live in? Yes I do agree. The proposed curriculum lacks age appropriateness and a lack of concern for those teaching the curriculum. How can I expect my daughter that is in Grade 2 to understand the history of Ancient Greece, Genghis Khan etc when she does not even have a background in Canadian or Albertan History?
- 2. Do you believe the current education funding formula is sufficient for your district? If not, how will you work to convince the province to provide sustainable and adequate funding? I do not believe there should be a lack of funding for any level of education more specifically taxpayer funded education. As a taxpayer in Alberta I would expect my dollars to be allocated to public education over private education. Also I have a very strong stance on the GOA decreasing funding to education as I believe children should not be given the short end of the stick in regards to education. I believe when individuals are provided with a workplace that appreciates them, a workplace that pays adequate remuneration, and they are given the resources to be successful develop and build a workforce that will go above and beyond the call of duty due to the respect given by the employer.
- 5. Will you oppose attempts from the provincial government to legislate against school staff including cuts to the Local Authorities Pension Plan, or restrictions on their right to strike? Yes. As mentioned above I believe school staff are undervalued and underpaid so I will continually advocate for our staff.
- 6. Do you support measures such as mask mandates, and vaccine mandates for staff to limit and reduce the spread of COVID-19 in your schools?
